- Tribal Enrollment cognitive testing (Aug 2016)
- 2017 Census Test
 - Site test:
 - Standing Rock Reservation
 - Colville Reservation and Off-Reservation Trust Land
 - National Sample
 - 80,000 housing units



Tribal Enrollment Questions in Cognitive Testing

Ver. A

1. On April 1st 2017, was Person 1 enrolled in any American Indian tribe or Alaska Native tribe, village, or corporation?

No, not enrolled

Ver. B

1. On April 1st 2017, was Person 1 enrolled in any American Indian tribe or any Alaska Native council, association, or community?

2. On April 1st 2017, was Person 1 a shareholder of any Alaska Native regional or village corporation?

Ver. C

1. On April 1st 2017, was Person 1 enrolled in any American Indian tribe or Alaska Native tribe or village?
