A short history of examples of requests for sensitive data might be helpful. The Policy Office may be able to help with this. DSEP should develop the list of sensitive topics/subpopulations, realizing that this list may change over time. If the DRB feels that something should be added to or taken off of the list at a given time, they will notify the DSEP. The program areas should also take responsibility in identifying sensitive data. If DRB needs guidance on an issue, they can ask the Policy Office. The Policy Office may in turn decide to ask the DSEP.
