(ITC), the US Census Bureau (Census) and US Customs and Border Protection (CBP) participated in the decision. We received notice of the denial via email on 5/22/18 from Vanessa Lee of the ITC to Cherie Tremaine of this requesting law firm. We also received letters dated 7/20/18 and signed by Cynthia Wilson, Chairman of the 484(f) Cmte, informing us of the decisions. For both petitions, we request all information on how the decision was made that there is not at least \$1 million dollars worth of trade in each of these products. For IPBC, we request information on how the decision was made that there were 3 or fewer importers of the product. We request all materials prepared and/or discussed by Census, CBP, the ITC, and/or any other agency, in connection with the 484(f) Cmte's denial of Troy's petitions.
