A question about a person's citizenship is used to create statistics about citizen and noncitizen populations. These statistics are essential for enforcing the Voting Rights Act and its protections against voting discrimination."</p> <p>I have attached a screen capture of it as of 7/09/2019. The section (see above) circled in red states that a citizenship question will be asked. It is now seven full business days since asking a citizenship question was ruled illegal for the 2020 Census by the Supreme Court of the United States of America.</p> <p>Specifically, the Supreme Court ruled that the contrived reason of "enforcing the Voting Rights Act" was a pretextual lie: "We cannot ignore the disconnect between the decision made and the explanation given," Chief Justice John Roberts.
