

Where state and county, and/or MCD boundaries coincide, the map shows the boundary symbol for only the highest-ranking of these boundaries. State and county names are followed by their FIPS code.

1 MCDs are symbolized and labeled only in the 12 strong MCD states: Connecticut, Maine, Massachusetts, Michigan, Minnesota, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, and Wisconsin.

2 Incorporated place name color corresponds to the incorporated place fill color.

3 The full census tract code consists of six digits with an implied decimal point between the fourth and fifth digits. For legibility on this map, the leading zeros have been stripped and the decimal point is shown. To translate a census tract number on the map to its full code, add as many zeros as needed to the left side of the number to reach six total digits and remove the decimal point before the last two digits. Example: Census tract number on the map "33.07" represents census tract code "033307".

Due to space limitations, some road names, along with other feature and geography names on the map, may not be shown.

This map supports the verification phase of the 2020 Participant Statistical Areas Program (PSAP).
