

<sup>2</sup> The CCD and CDP boundaries represent statistical entities only and are not updated through the BAS.

<sup>3</sup> Incorporated place name color corresponds to the incorporated place fill color.

<sup>4</sup> Geographic offsets and corridors are displayed directly on the road. Geographic offsets and corridors represent the road right-of-way for both or one side of a road and typically extend thirty feet from the road.

Due to space limitations, some road names, along with other feature and geography names on the map, may not be shown.

The Census Bureau stores primary and alternate road names, but only primary road names are used to label the roads on these maps.


