MONTHLY WHOLESALE TRADE: SALES AND INVENTORIES May 2008


Sales. The U.S. Census Bureau announced today that May 2008 sales of merchant wholesalers, except manufacturers' sales branches and offices, after adjustment for seasonal variations and trading-day differences but not for price changes, were \$397.4 billion, up 1.6 percent (+/-0.5%) from the revised April level and were up 13.7 percent (+/-1.2%) from the May 2007 level. The April preliminary estimate was revised upward \$0.7 billion or 0.2 percent. May sales of durable goods were down 0.2 percent (+/-0.8%)* from last month, but were up 7.6 percent (+/-1.7%) from a year ago. Compared to last month, furniture and home furnishings were down 4.0 percent, while sales of metals and minerals, except petroleum were up 2.9 percent. Sales of nondurable goods were up 3.2 percent (+/-0.8%) from last month and were up 19.2 percent (+/-1.7%) from last year. Sales of petroleum and petroleum products were up 7.5 percent from last month and sales of apparel, piece goods, and notions were up 5.2 percent.

Inventories. Total inventories of merchant wholesalers, except manufacturers' sales branches and offices, after adjustment for seasonal variations but not for price changes, were \$431.0 billion at the end of May, up 0.8 percent (+/-0.3%) from the revised April level and were up 8.7 percent (+/-1.2%) from a year ago. The April preliminary estimate was revised upward \$0.2 billion. End-of-month inventories of durable goods were up 0.8 percent (+/-0.5%) from last month and were up 5.6 percent (+/-1.2%) from last May. Inventories of computer and computer peripheral equipment and supplies, were up 3.5 percent from last month and inventories of metals and minerals, except petroleum were up 2.7 percent. End-of-month inventories of nondurable goods increased 0.7 percent (+/-0.5%) from April and were up 14.2 percent (+/-2.0%) compared to last May. Inventories of beer, wine, and distilled alcoholic beverages, were up 3.0 percent from last month and inventories of Drugs and druggists' sundries were up 1.2 percent.

Inventories/Sales Ratio. The May inventories/sales ratio for merchant wholesalers, except manufacturers' sales branches and offices, based on seasonally adjusted data, was 1.08. The May 2007 ratio was 1.13.

Reliability of the Estimates

Because the estimates presented in this report are based on a sample survey, they may contain sampling error and nonsampling error.

Sampling error is the difference between the estimate and the result that would be obtained from a complete enumeration of the sampling frame conducted under the same survey conditions. This error occurs because only a subset of the entire sampling frame is measured in a sample survey. Standard errors and coefficients of variation (CV), as given in Table 2 of this report, are estimated measures of sampling variation.

The margin of sampling error, as used on page 1, gives a range about the estimate which is a 90-percent confidence interval. If, for example, the percent change estimate is +1.2 percent and its estimated standard error is 0.9 percent, then the margin of sampling error is $\pm 1.645 \times 0.9$ percent or ± 1.5 percent, and the 90 percent confidence interval is -0.3 percent to +2.7 percent. If the interval contains 0, then one does not have sufficient statistical evidence to conclude at the 90 percent confidence level that the change is different from zero and therefore the change is not statistically significant. Estimated changes shown in the text are statistically significant unless otherwise noted. For a monthly total, the median estimated coefficient of variation (CV) is given. The resulting confidence interval is the estimated value $\pm 1.645 \times CV \times$ (the estimated value). The Census Bureau recommends that individuals using estimates in this report incorporate this information into their analyses, as sampling error could affect the conclusions drawn from the estimates.

Nonsampling error encompasses all other factors that contribute to the total error of a sample survey estimate. This type of error can occur because of nonresponse, insufficient coverage of the universe of wholesale businesses, mistakes in the recording and coding of data, model error, and other errors of collection, response, coverage, or processing. Although nonsampling error is not measured directly, the Census Bureau employs quality control procedures throughout the process to minimize this type of error.

Description of the Survey

The Census Bureau conducts the Monthly Wholesale Trade Survey (MWTS) to provide national estimates of monthly sales, end-of-month inventories, and inventories-to-sales ratios by kind of business for wholesale firms located in the United States. Specifically, the MWTS covers wholesale merchants who sell goods on their own account and include such businesses as wholesale merchants or jobbers, industrial distributors, exporters, and importers. Sales offices and branches maintained by manufacturing, refining, or mining firms for the purpose of marketing their products are not covered in this report. Also excluded is NAICS Industry Group 4251: Wholesale Electronic Markets and Agents and Brokers.

The MWTS sample was selected using a stratified, one-stage design with strata defined by kind of business (e.g., Automotive, Furniture, Lumber, etc.) and annual sales size. The sample includes firms of all sizes and is updated on a quarterly basis to account for new wholesale firms, deaths, and other changes to the wholesale universe. Each month, questionnaires are mailed to employer firms selected in a probability sample of approximately 4,500. Approximately 76% of those mailed provided data for this reporting period. Data for nonresponding firms are imputed based on data for similar-sized firms classified in the same kind of business. Approximately 27% of the total sales estimate and 28% of the total end-of-month inventories estimate is based on imputed data. Monthly sales and inventories estimates are obtained by summing weighted data (either reported or imputed). The monthly estimates are benchmarked to annual survey estimates and are adjusted for seasonal variation and trading-day differences. Individuals who use estimates in this report to create new estimates should cite the Census Bureau as the source of only the original estimates.
