

Corrected 2010 Census Total Population, Household Population, Group Quarters Population, Total Housing Unit, Occupied Housing Unit, and Vacant Housing Unit Counts for Governmental Units

Note: Corrected counts are the result of the 2010 Census Count Question Resolution (CQR) Program.

Federal Register/Vol. 75, No.101/Wednesday, May 26, 2010 (Abstract): *The CQR program is not a mechanism or process to challenge or revise the population counts sent to the President by December 31, 2010, which are used to apportion the U.S. House of Representatives.*

The state level census counts will always be presented, regardless of whether or not there is a CQR change to the counts for the state total(s). In this table, the number of governmental units for the state counted as "affected" includes any change to the totals for the state, counties, functionir county subdivisions, and incorporated places. Below the state level, the tables will present census counts only for those governmental units in which a CQR change has occurred, with one exception. When a CQR change occurs in a place that is in more than one county, the table will display census counts for all the county parts, regardless of whether each part had a CQR change.
