2018 Annual Business Survey (ABS): Characteristics of Business Owners (CBO) Dataset

Accessible via the Application Programming Interface (API)

Estimates are provided for owners (classifiable by sex, ethnicity, race and veteran status) of employer firms that responded to the characteristic(s) listed below. New for the ABS API, the characteristics have two variables; QDESC_LABEL (shown in the parenthesis below), which describes the question asked, and BUSCHAR_LABEL, which denotes the answer (see page 4 and on for details).

- How the owner initially acquired the business (ACQBUS)
- Year the owner acquired ownership of the business (YRACQBUS)
- Owner's primary function(s) in the business in 2017 (PFNCT)
- Owner's average number of hours per week spent managing or working in the business in 2017 (HRSWRKD)
- Whether the business was the primary income source for owner (PRMINC)
- Whether the owner owned another business prior to establishing, purchasing, or acquiring the business (NUMPRIORBUS)
- Owner's highest degree or level of school completed prior to establishing, purchasing, or acquiring the business (EDUC)
- Field of the owner's highest degree completed prior to establishing, purchasing, or acquiring the business (FLDEDUC)
- Owner's age as of December 31, 2017 (OWNRAGE)
- Whether the owner was born a U.S. citizen (USBORNCIT)
- If the owner is disabled as a result of an incident occurring during military service (DISVETRN)
- Owner's specific veteran characteristics (VETSPECIFIC)
- Owner's reasons for owning the business (REASONOWN)
- Status of the owner's most recently owned prior business (PRIORBUSTAT)

Data are tabulated by:

- Geography (U.S., states, metro areas, counties, and economic places)
- Industry sector (2-digit 2017 North American Industry Classification System code (NAICS2017) and meaning of code (NAICS2017_LABEL)) [See <https://www.census.gov/eos/www/naics/> for detailed information.]

Technical Notes:

Detail may not add to total due to rounding or because a Hispanic owner may be of any race. Moreover, each owner had the option of selecting more than one race and therefore is included in each race selected.

The 2018 Annual Business Survey asked for information for up to four persons owning the largest percentage(s) of the business. Percentages are for owners of respondent firms with paid employees only, and are not recalculated when users may resort the datasets. Percentages are based on total reporting within a sex, ethnicity, race, veteran status, and/or industry group for the characteristics tabulated in this dataset. To build valid API queries, data users will need to refer to the following codes.

If any one **person** owned 10 percent or more of the business in 2017, the respondent was asked to provide the sex, ethnicity, race, and veteran status for up to four persons owning the largest percentage(s) of the business in 2017. Please refer to these questions and valid codes (listed by QDESC code and label in the order asked on the questionnaire) for a better understanding of the information collected on the 2018 ABS-1 report survey, which resulted in the classification of majority business ownership. Please note that only the race question instructed the respondent to **"Select all that apply."**
