Page 4

- First column, first paragraph, first line – Text was revised to “The 2011 Survey revealed that almost 90 million U.S. residents...”
- “Total Wildlife-Related Recreation” table – The estimate in the “Participants” (first row) was revised to “89.6”

Page 6, “2006-2011 Wildlife-Associated Recreation Comparison of Participants” table

Page 144, first column

Page 146

- First column, paragraph #2
 - A period was inserted after “2” paragraph indicator.
 - Fourth line of text – The spelling error in “interviewed” was corrected.
- Second column, paragraph #4, sixth line – “stratum” was revised to “strata”
- Third column
 - First paragraph, second line – “which” was revised to “whom”
 - Second paragraph, fifth line – “within wildlife-watchers” was revised to “within the wildlife-watchers”

Page 147, first column, fourth paragraph – “and the statistical review of reports” was deleted from the text.

Page 159, “Table D-9. Parameters a, b, and c for Calculating Approximate Standard Errors for Days or Trips for the Detailed Sportspeople Sample” – The first three values on the sixth data line were updated.

A revision to the National Report was released in September 2013. The errata from the September revision documented the following items:

Page iii, “Table of Contents”

- “State Tables.....94” was inserted after the “Wildlife-Watching Tables....85” row.
- The Appendixes’ page numbers were revised due to the insertion of the state-level tables.

Page v, “List of Tables”

- The “State Wildlife-Related Recreation” tables and their respective pages were inserted into the list of tables.

Page 3, third text column – The “State-Level Estimates” paragraph was deleted as the revised report includes state-level data.

Page 31, “Hunters by Education, Race, and Ethnicity” table – Under the Race section, the “Other” category data value was revised to “0.4” as to be consistent with the data in Table 10.

Page 93, Table 44 – Values in data rows 2 through 4 were updated.

Page 94, Tables 46 and 47 – These tables were deleted and replaced with state-level tables 46 through 65.

Pages 120 through 161 – The appendixes reflect revised page numbers due to the inclusion of the twenty state-level reports.

Page 121 through 130

- The “... Sample size too small (less than 10) to report reliably.” footnote on Tables B-1, B-2, B-3, B-5, and B-7, was revised to state “...Sample size too small (less than 10) to report data reliably.”
- Table B-9 was renamed to Table B-12.
- Tables B-9, B-10, and B-11 were inserted to reflect state-level data.

Page 145

- Second column, first paragraph – “16,400” and “31” were bolded.
- Third column, fourth paragraph – “33” was bolded.

Page 155 through 161

- Table D-5 was replaced with a state-level table.
- Tables D-6 through D-11 were added to the report.
