3. A. Property taxes (code T01)

Include

- Amount of real and personal property tax collected for all municipal funds
- Delinquent tax collections, penalties and interest
- Proceeds and costs of tax sales and advertising

3. B. Local sales taxes

1. General sales and gross receipt taxes (code T09)

Include

- Amount of municipal general sales tax remitted by the state comptroller

3. Amusements sales tax (code T11)

Include

- Local admission tax on amusements

6. Public utilities sales tax (code T15)

Include

- Franchise tax on gross receipts (street rental tax)

8. Other sales tax (code T19)

Include

- Hotel occupancy tax receipts
- Short-term motor vehicle rental tax

3. C. Licensing and permit taxes

2. Amusements licensing and permit taxes (code T21)

Include

- Amounts collected for license fees on coin operated amusement machines, as well as other amusement machines subject to regulation

5. Occupation and business licensing and permits (code T28)

Include

- Inspection and examination fees required in connection with the issuance or renewal of a business license or permit

6. Other licensing and permits taxes (code T29)

Include

- Bicycle tax
- Building permits
- Dog tax

4. Intergovernmental revenues

D. Health and/or hospitals – From the State (code C42)

Include

- Hospital construction grants
- Alcoholism grants

M. General support - From the State (code C30)

Include

- The distribution to this government of the mixed beverage tax

PART 3 – EXPENDITURES

11. Personnel expenditures (code Z00)

Include

- Salaries and wages for all employees, full-time and part-time
- Salaries paid for employees of any utility owned and operated by this government
- Salaries in gross amount before deductions for income tax, social security, or retirement coverage
