##### 6. Public utilities sales tax (code T15)

###### Include

- Franchise taxes based on gross receipts
- Franchise fees

##### 8. Other sales tax (code T19)

###### Include

- Transient room tax
- Car rental tax

#### 3. C. Licensing and permit taxes

##### 5. Occupation and business licensing and permit taxes (code T28)

###### Include

- Inspection and examination fees in connection with the issuance of or renewal of a business license or permit

##### 6. Other Licensing and permit taxes (code T29)

###### Include

- Any other licenses or permits
- General system development charges (SDC's)
- Other construction and land development taxes

#### 5. E. Other taxes

##### 4. Other taxes (code T99)

###### Include

- Transit tax revenue if applicable to this government

#### 4. Intergovernmental revenues

##### M. General support – From the State (code C30)

###### Include

- State liquor and cigarette taxes
- State revenue sharing (ORS 221.770)

##### N. All other – From the State (code C89)

###### Include

- Reimbursements for emergency services (911)
- Library
- Marine board
- Parks grants
- Planning and tourism grants
- Other grants and reimbursements

#### 5. Other than tax and intergovernmental revenues

##### 5.B. Other sales and service revenues

##### 13. Other sales and services revenues (code A89)

###### Include

- Charges or fees collected for fire and police
- Charges for ambulance services
- Other miscellaneous services

### PART 3 - EXPENDITURES

#### 11. Personnel expenditures (code Z00)

##### Include

- Salaries and wages for all employees, full-time and part-time
- Salaries paid for employees of any utility owned and operated by this government
- Salaries and wages in gross amounts before deductions for income taxes, social security, or retirement coverage
