We request your participation with the **2019 Annual Survey of School System Finances**. The U.S. Census Bureau conducts this survey in conjunction with the National Center for Education Statistics (NCES). This survey provides up-to-date school district finance data that is essential to the work of the U.S. Congress, state legislators, government finance officers, education research organizations, and many others.

State education agencies report most of the school district finance data requested for this survey. State financial reports, however, often do not contain details regarding school district assets held in various nonretirement funds, such as general, debt service, and bond funds. In addition to assets, we are also requesting information on long-term and short-term debt, which is also often not available in state financial reports.

Please use the enclosed form as a worksheet prior to reporting online. Website and log-in information can be found on the front page of the form. Online reporting is easy, reduces costs, and decreases processing times. You may elect to return the completed form in the enclosed envelope instead of responding online.
